For 38 years, Cultural Survival has assisted Indigenous communities in dozens of countries, both with on-the-ground projects and advocacy campaigns. Our all-volunteer Guatemala Radio Program now has over 200 stations and is reaching well over a million Indigenous Mayans in their own languages. It will soon expand into other countries in the region. In May 2009, our Endangered Native American Languages program hosted a Language Summit at the National Museum of the American Indian that helped influence the United States government to quadruple this year's federal funding for Native language revitalization to nearly \$12 million. With the addition in 2009 of our Global Response program, Cultural Survival now sends researchers to Indigenous communities to investigate and design powerful advocacy campaigns when they uncover
